1919 Legacy Society Information

Located in historic Gettysburg, PA, WellSpan Gettysburg Hospital has been serving the communities of Adams County and northern Maryland for 100 years. The 1919 Legacy Society was established in honor of the year two philanthropic visionaries made an impact on the community's future health care.

In 1919, John and Annie Warner broke ground to build a hospital for the people of Adams County after an outbreak of the Spanish flu killed more than

250 individuals. John Warner, a Gettysburg native and son of German immigrants, held various jobs in the community as a teacher, banker, merchant and chief of the fire company. He married Annie Bream and while they had no children of their own, both John and Annie were very community minded.

Donating six acres of pastureland and \$25,000 toward the establishment of the hospital, Mr. Warner laid the cornerstone of the structure on July 1, 1919 in honor of his wife, Annie. While the building did not admit its first patient until 1921, these two community members saw a need, and they even inspired their friends and neighbors to join them in their charitable endeavors.

While the needs of the community have evolved and advancements in health care have been made, philanthropic giving and leaving a legacy is still a part of WellSpan Gettysburg Hospital's identity as we provide the best quality care, right in your backyard.

former Gettysburg Hospital President, and Linda, a retired Littlestown third-grade teacher, have seen firsthand how WellSpan Gettysburg Hospital and the community have grown over the years.

Steve especially remembers the day Gettysburg Hospital and York Hospital merged and eventually became what is known as WellSpan Health, because he was a key leader in making that exciting announcement. Steve loves being a part

Additionally, Steve and Linda both believe in the importance of keeping care local. “I like having my family physician and specialty doctors available in the community,” says Linda.

“The local heritage and history of this community, especially at WellSpan Gettysburg Hospital, is important to us,” says Steve. “We want to see health care in this community continue to thrive and grow to meet the needs of future generations.” That’s why Steve and Linda have planned for their donor-advised fund to eventually fund an endowment. This ensures their giving to the hospital and other beloved charities can continue in perpetuity.

Steve and Linda’s generous leadership and giving have created a legacy that will endure to help Adams County residents for generations to come.

Some of the Easiest Ways to Make an Impact

Bequests

A bequest is the most common way of leaving a legacy. A bequest is a gift of cash, securities or other property designated via an estate plan.

- Make a bequest to the Gettysburg Hospital Foundation in your will or trust (a specific dollar amount or asset, a percentage of your estate, or a gift of the balance of your estate);
- Leave all or part of your retirement assets to the Gettysburg Hospital Foundation; or
- Name the Gettysburg Hospital Foundation as owner or beneficiary of a life insurance policy.

Change of Beneficiary Form

Filling out a “Change of Beneficiary Form” for a retirement account or life insurance policy is a simple process, not requiring changes to your will or trust. More importantly, retirement plans (IRA, 401k, 403b, pension or other deferred plans) are often the largest assets in your estate – and the most heavily taxed.

If you leave these funds to someone other than a spouse, a large portion of these assets might be lost. Simply complete a change of beneficiary form to leave all or a portion of the plan to the Gettysburg Hospital Foundation. Gettysburg Hospital Foundation gets the full value of these funds. You can also recommend the Gettysburg Hospital Foundation as beneficiary of the remainder of your Donor Advised Fund.

Gifts from your IRA

You do not need to delay a gift from your IRA. The now-permanent Charitable IRA Rollover allows you to satisfy your required minimum distribution, substantially reduce taxable income and support the Gettysburg Hospital Foundation. If you are over age 70½, you can donate up to \$100,000 from your IRA to the Gettysburg Hospital Foundation avoiding any federal income tax on these funds. Our office can assist you with language for requesting your fund administrator to effect this donation.

Transfer of Other Assets

Common bank accounts (i.e., checking, savings and money market accounts) can be transferred to a beneficiary by completing a “**payable on death**” (POD) form. This allows assets to transfer outside the probate process.

A similar method using a “**transfer on death**” (TOD) form is typically used for stocks, bonds, brokerage accounts, mutual funds and real estate.

Life Insurance

A gift of life insurance to the Gettysburg Hospital Foundation is a great way to establish a legacy. There are several options:

- Donate a paid-up policy that you do not need as an immediate gift;
- Change the beneficiary designation of a current policy for a future gift to the Gettysburg Hospital Foundation; or
- Purchase a new policy and name the Gettysburg Hospital Foundation as owner and beneficiary.

I Give to Help Those in Need



Betty Fair spent the final nine years of her career working as a patient financial counselor for WellSpan Gettysburg Hospital before retiring in 2011. Together with her husband, a custodian in the public school system, they raised two children and diligently saved for retirement. But it wasn't their hard-earned nest egg that

inspired Betty to make a planned gift to the Gettysburg Hospital Foundation – it was simply a desire to give back to a community that had given so much to her and her family.

“You don't have to be rich to give,” says Betty. “We're certainly not. I assigned a small portion of my life insurance to the Foundation. I feel a relationship with the hospital, and I want that relationship to continue even after I'm gone. I trust the hospital will put the gift toward whatever is needed most at the time.”

In her role as a patient financial counselor, Betty met many people who struggled to make ends meet while facing a challenging diagnosis or a long course of treatment. On many occasions, she witnessed the Gettysburg Hospital Foundation


help patients buy groceries or pay for prescriptions.

“I could have been the one sitting in that chair needing assistance,” Betty reflects. “It's about connecting people to the resources they need, and I wanted to be a part of that. I truly believe that anyone can give, and no gift is too small.”

Philanthropy and volunteering have been central to Betty's life. She helped with the United Way campaign and participated in the hospital's employee giving program. Today, her focus has turned to her family and spending time with her grandchildren.

Charitable Gift Annuities

A Charitable Gift Annuity offers you steady payments for life with funds eventually going to the Gettysburg Hospital Foundation. This can add an extra measure of financial security in your retirement.

You can use a range of assets (cash, stocks, bonds, commodities, retirement assets and more). You may be able to deduct a significant part of your gift immediately, and part of the annuity payments you receive may be tax-free.

A deferred annuity can increase the annuity payments. Charitable Annuity Trusts offer additional flexibility depending on your needs.

Real Estate

A gift of your appreciated property – such as your home, vacation property, vacant land, farmland or commercial property – may be an ideal way for you to leave a lasting legacy.

Donating appreciated stock or bonds is a common and easy way to benefit our mission. It is also possible to donate all or a portion of privately held business interests. This takes more discussion with and assistance from relevant financial and legal professionals. But yes, it is possible, and can make a wonderful gift!



Farm Commodities

Make a gift of what you grow and harvest, from farm crops like grain to animal products like dairy, honey and more. You can deduct the cost of production from your taxes, and you may qualify for other tax benefits as well.
